- 4. The latest books (2010 and after) are to be included in the list of text/reference books
- 5. The course outcomes of the course '14CSPV0 Design Patterns' are to be changed.
- 6. Based on the competency, exemptions may be given in registering courses by lateral entry students.
- 7. Financial Technology may be considered as the theme area for the MCA Degree Programme.
- 8. 'Design' Courses are to be included in the M.E. (Mechatronics) degree programme
- 9. Mathematics courses are to be introduced such that it meets the requirements of 'Design' courses in PG programmes
- The course on 'Design Patterns' may be offered as General Elective Courses in UG Programmes.
